Warranty Information

Floor Coating Systems: Limited Lifetime Warranty on Flooring: Contractor warrants its floor coating system against peeling, lifting and wear for as long as you own your home. Warranty does not apply to floor damage caused by abnormal use, unordinary wear and tear, abuse, neglect, accident or failure to maintain the installation properly. While the floor system is stain resistant, warranty does not cover staining since the root cause of the stain and the level of care given to treat the stain is outside our control. Certain car tires can contain plasticizers which can leach into the floor and cause tire marks and yellow staining. Warranty does not cover the garage apron, or any other outdoor areas constantly exposed to the elements. Warranty does not apply in cases of improper substrate construction and excludes cracking in the underlying concrete which causes damage to the coating. Coating failure occurring in specific areas does not constitute failure of the entire floor. Contractor shall make the determination of whether a floor shall be spot repaired or replaced. In the case of a warranty repair, every effort will be made to achieve matching color tone, chip mix or topcoat gloss consistency, however this may not always be possible. Customer shall be responsible for the removal and return of garage contents and rental of any portable storage containers required during repair or re-coating work. Warranty shall become invalid if full payment for services rendered is not received per our standard payment terms. Warranty may not include labor charges beyond one year from the installation date.

Proof of purchase is required when making a warranty claim. All warranty claims must be in writing. To make a warranty claim, contact EncoreGarage of NJ. EncoreGarage will determine in its sole and absolute discretion, whether: (a) the floors has been properly maintained, and (b) the warranties granted herein are applicable and not otherwise subject to the exclusions hereunder. If a claim is determined to be subject to the warranties hereunder, the EncoreGarage will repair or replace the items subject to the claim at EncoreGarage's expense. A claim hereunder will be your sole and exclusive remedy. This warranty is non-transferable and applies only to the original buyer. This warranty may not be assigned or transferred.
